NOTICE OF PUBLIC HEARING

The City Council of the City of Camarillo will conduct a public hearing on **Wednesday, September 29, 2021** at 7:00 p.m. in the City Hall Council Chambers, 601 Carmen Drive, Camarillo, on the following agenda item:

Final Draft 2021-2029 Housing Element Update and Negative Declaration 2021-9

The State housing law mandates that all jurisdictions periodically update their Housing Element. The City's 2013-2021 Housing Element will expire on October 15, 2021. To comply with this State mandate, the City must prepare, adopt, and submit the adopted 2021-2029 Housing Element Update to the California Department of Housing and Community Development (HCD) by October 15, 2021. The update will cover an 8-year period from October 15, 2021 through October 15, 2029.

In compliance with the California Environmental Quality Act (CEQA) and the State CEQA Guidelines, as well as the City's environmental guidelines, an initial study was conducted to evaluate the potential effect of the project on the environment. Based on the findings of the Initial Study, it has been determined that the project could not have a significant effect on the environment, and a Negative Declaration (ND 2021-9) has been prepared.

The City Council is requested to review the final draft 2021-2029 Housing Element Update and ND 2021-9, open a public hearing, accept public input, and take action on the approval and adoption of the final draft 2021-2029 Housing Element Update and ND 2021-9. The City Council may make recommendations or other adjustments deemed to be appropriate.
